Each contestant agrees to be responsible for all damages or injures that occur to the contestant or any property or animal owned or used by the contestant and to hold harmless the **Association** and **Committee**, for any such injuries or damages. The contestant acknowledges that participating in the **Rodeo**, involves significant danger and risk of injury or death to person and on behalf of contestants personal representatives, heirs, spouse and next of kin, agrees and understands, as a condition of participating in the **Rodeo**, contestant will hold harmless the **Association and Committee**, for any and all injures or damages to the contestant or any property or animal owned or used by the contestant, and agrees to personally assume all responsibility for any and all injures or damages that may occur as a result of participating in this event.
