Each contestant agrees to be responsible for all damages or injuries that occur to the contestant or any property or animal owned or used by the contestant and to hold harmless the Association and Committee, for any such injuries or damages. The contestant acknowledges that participating in the Rodeo, involves significant danger and risk of injury or death to person and on behalf of contestants personal representatives, heirs, spouse and next of kin, agrees and understands, as a condition of participating in the Rodeo, contestant will hold harmless the Association and Committee, for any and all injuries or damages to the contestant or any property or animal owned or used by the contestant, and agrees to personally assume all responsibility for any and all injuries or damages that may occur as a result of participating in this event.

The contestant further agrees that any expenses or attorney fees incurred by the Association and Committee for a breach of this agreement shall be paid by the contestant. The contestant voluntarily accepts all risks associated with in the Rodeo and again waives al liability of the Association and Committee and agrees to hold harmless the Association and Committee for all injuries to the contestant's person or property owned or used by the contestant.
